

**HAGGEN LUCKY DAY PROMOTION 2020
OFFICIAL RULES**

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

OFFERED ONLY TO LEGAL RESIDENTS OF WASHINGTON, AGED 18 YEARS OR OLDER.

1. BRIEF PROGRAM DESCRIPTION: The Haggen Lucky Day Promotion 2020 (the "Promotion") sponsored by Safeway Inc. dba Haggen (the "Sponsor") consists of an instant-win game (the "Instant-Win Game" or "Game") and a Grand Prize sweepstakes (the "Grand Prize Sweepstakes" or "Sweepstakes"), as fully described below.

2. ELIGIBILITY: The Promotion is open only to legal residents of Washington who are 18 years of age or older. Employees of Sponsor and its parents/affiliates/subsidiaries, along with employees of Sponsor's advertising or promotion agencies or other individuals engaged in the management of the Promotion (collectively, the "Promotion Parties"), and members of the immediate families (spouses and parents, children and siblings and their spouses) and persons living in the same household of such individuals are not eligible to participate. Sponsor's determinations of eligibility are final and may be made at any time. Void where prohibited or restricted by law.

3. AGREEMENT TO OFFICIAL RULES: Participation in the Promotion constitutes participant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsor and its service providers, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein. Any participant may be disqualified at Sponsor's sole discretion if he/she fails to comply with any of the terms of these Official Rules.

4. INSTANT-WIN GAME:

4a. GAME CARDS: There are two (2) ways for eligible participants to obtain an official Haggen Lucky Day Game Card (a "Game Card") from March 11, 2020 through April 7, 2020 (or while supplies last for a specific participating Haggen store): (i) by making a qualifying purchase; or (ii) by mail (using a form obtained in-store):

i. To obtain a Game Card by making a qualifying purchase: Eligible participants will receive one (1) Game Card by making a qualifying purchase of \$50 or more in a single transaction at a participating Haggen store from March 11, 2020 through April 7, 2020 (the "Game Period"), while supplies last and subject to the total daily limit stated below in this section. The following items do not count toward a qualifying purchase: alcohol, tobacco, postage stamps, gift cards, prepaid cards, prescription drugs, lottery tickets, catering orders, or sales tax.

ii. To obtain a Game Card by mail (using a form obtained in-store) without purchase: First, visit a participating Haggen store during the Game Period and request an official no-purchase Game Card request form ("Request Form") at Guest Services (a maximum of 10 Request Forms can be requested per person, per day, per participating Haggen store). Then, hand print the requested information on a Request Form (including the date of your store visit) and mail it ALONG WITH A SELF-ADDRESSED, STAMPED ENVELOPE to: Haggen, Attn: Lucky Day Scratch Ticket Request, 400 Sequoia Dr., Ste. 202, Bellingham, WA 98226. Each such request must be mailed separately in a separate, hand-addressed, stamped envelope, to be postmarked by April 7, 2020 and received by April 13, 2020. Only original Request Forms will be accepted; no mechanical reproduction of Request Forms or facsimiles will be permitted. In response to your eligible request, one (1) Game Card will be returned to you in your self-addressed, stamped envelope, while supplies last and subject to the total daily limit stated below in this section. Multiple Game Card requests must not be mailed to Sponsor in the same envelope, and Sponsor will not return more than one (1) Game Card in a single self-addressed, stamped envelope.

Limit ten (10) Game Cards per eligible person, per day, regardless of how the Game Cards are obtained. Note that Game Cards may also be referred to as "Scratch Tickets" in Promotion advertising materials. Note that each participating Haggen store will offer a separate Game prize/offer structure and its own separate supply of Game Cards, as described in Exhibit A below. For this reason, the supply of Game Cards at a certain participating Haggen store may run out sooner than another participating Haggen store (if a store's supply runs out before the end of the Game Period), and the odds of receiving a particular prize/offer may be different from

one store to another, as fully detailed in Exhibit A below.

4b. TO PLAY THE INSTANT-WIN GAME: With the side of a coin, gently rub off the scratch-off area on your Game Card to reveal a message, which will correspond to one of the following categories:

- a **“Prize Message”**, which would indicate the Game prize you have won, subject to verification of the Game Card, your eligibility, and your continued compliance with these Official Rules. If your Prize Message indicates a free product prize, present the Game Card at checkout along with the applicable product in a future transaction at a participating Haggen store, no later than April 28, 2020. Free product prize claims are only valid for a single applicable item, per applicable Game Card. If your Prize Message indicates a \$25 or \$100 Haggen Gift card prize, take the Game Card to Guest Services at a participating Haggen store no later than April 28, 2020, and request prize claim instructions (Guest Services will provide you with the prize, following verification of the Game Card and your eligibility, and your compliance with Sponsor’s prize claim process). Gift card prizes are subject to the terms, conditions, and restrictions as printed or referenced on the gift card.
- a non-winning **“Discount Message”**, which would indicate which discount offer you may redeem using the non-winning Game Card, subject to verification of your eligibility and your continued compliance with these Official Rules. To redeem a discount offer, present the Game Card at checkout along with the applicable product(s) in a future transaction at a participating Haggen store, no later than April 28, 2020. Discounts are not valid for alcohol, tobacco, postage stamps, gift cards, prepaid cards, prescription drugs, lottery tickets or catering orders. No cash back. Product-specific discounts will only be applied to a single item, per applicable Game Card. Discounts cannot be applied to a prior order (including but not limited to the order for which the Game Card was given, if the Game Card was obtained via purchase).
- A non-winning **“Sweepstakes Entry Message”**, which would indicate that you may use the non-winning Game Card to enter the Sweepstakes, as further detailed in Section 5 below. Note that the \$1,000 Haggen Gift Card prizes are only made available in the Sweepstakes, and are not available to be won in the Instant-Win Game.

4c. ADDITIONAL INSTANT-WIN GAME TERMS: See Exhibit A below for per-store prize/offer quantities and odds. All Game Cards are void if not redeemed/used by April 28, 2020, or if transferred or duplicated. All prize/offer claims are subject to verification and are void if the result of an error. In Sponsor’s sole discretion, potential Instant-Win Game winners may be required to complete an affidavit of eligibility, a liability release, and (where legal) a publicity release, which, if required, will be presented to the potential winner at the time of prize claim, and must be returned to Sponsor within seven (7) days, or the applicable prize will be forfeited. Proof of identity, age, and/or legal residence may be required to claim a prize. Any Instant-Win Game participant may be disqualified (and the applicable prize/offer forfeited) in Sponsor’s sole discretion if: (a) the participant fails to provide any required information within the required time period; or (b) the participant fails to comply with any of the terms of these Official Rules. **Except as necessary to complete the prize/offer claim process (or as further instructed by Sponsor), participants are expressly prohibited from sharing images of a Game Card with others (whether via social media or by any other means), and participants hereby agree that doing so may invalidate their prize/offer claim, in Sponsor’s sole discretion.** All prize/offer claims submitted become the sole property of Sponsor and will not be returned. Game Cards are void if not obtained in accordance with these Official Rules, or if any part is forged, illegible, counterfeited, incomplete, mechanically reproduced, photocopied, altered, mutilated or tampered with in any way, or if they contain printing, production, typographical, mechanical or other errors. Releasees (as defined in Section 7 below) will have no liability for damaged Game Cards or Game Cards containing printing, production, typographical, mechanical or other errors, except the Sponsor may replace such Game Cards with other Game Cards or a replacement opportunity of equivalent odds and value, while supplies last. In no event will Sponsor be obligated to award more than the stated number of prizes/offers. Participant assumes all risk of loss or damage to, or destruction of, Game Card. You are not a prize/offer recipient until your Game Card and eligibility have been verified by Sponsor and you have complied with these Official Rules, all as determined by Sponsor in its sole discretion. By participating in the Instant-Win Game, you agree that your personal information may be used by the Promotion Parties for the purpose of verification and prize/offer fulfillment in the event that you are a potential prize/offer recipient. **Unclaimed, unused and/or forfeited Instant-Win Game prizes and offers will not be awarded/provided.**

5. GRAND PRIZE SWEEPSTAKES:

5a. TO ENTER THE GRAND PRIZE SWEEPSTAKES: If you reveal the non-winning offer message “Enter for

a chance to win a \$1,000 Haggen Gift Card" on your non-winning Game Card, you may legibly hand print your full name and phone number on the back of your Game Card and place the Game Card in the designated Sweepstakes entry box at Guest Services in a participating Haggen store by close of business on April 28, 2020, to receive one entry into that store's \$1,000 Haggen Gift Card drawing. Such Game Cards become property of Sponsor and will not be acknowledged or returned. No photocopies or mechanical reproductions of such Game Cards will be accepted for entry into the Sweepstakes. By entering the Grand Prize Sweepstakes, you agree that your personal information may be used by the Promotion Parties for the purpose of verification and prize fulfillment in the event that you are chosen as a potential winner. Any attempt by a person to use multiple identities to gain more Game Cards or entries than permitted by these Official Rules shall result in disqualification, at Sponsor's sole discretion. By participating, participants warrant and represent that all personal information provided in their entry is truthful, current and accurate, and is participant's own information. Entry and prize/offer claim information becomes the exclusive property of Sponsor upon submission. Proof of submission of entry does not constitute proof of receipt of entry. It is the sole responsibility of the participant to notify the Sponsor in writing if the participant changes his or her phone number during the Sweepstakes. Potential winners may be required to provide evidence (to the Sponsor's satisfaction) that they are the eligible person associated with a winning entry. In the event a dispute regarding the identity of the person who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.

5b. GRAND SWEEPSTAKES RANDOM DRAWING - PRIZES - ODDS OF WINNING: On or about May 15, 2020, Promotion Mechanics, Inc. (an independent judging organization) will conduct fifteen (15) separate random drawings (one drawing from among the eligible Sweepstakes entries received at each of the fifteen [15] participating Haggen stores) to award one (1) Grand Prize per participating Haggen store. Each Grand Prize will consist of a \$1,000 Haggen Gift Card. Odds of winning depend on the number of eligible Sweepstakes entries received at the applicable Haggen store. Gift card prizes are subject to the terms, conditions, and restrictions as printed or referenced on the gift card. See winner notification details in Section 5c below. **Limit one (1) \$1,000 Haggen Gift Card Prize per household.**

5c. GRAND PRIZE WINNER NOTIFICATION/VERIFICATION/ADDITIONAL PRIZE RESTRICTIONS: Each potential Grand Prize Sweepstakes winner will be notified by Promotion Mechanics, Inc. by phone at the phone number provided on the applicable Grand Prize Sweepstakes entry, to verify his/her eligibility and ability to accept the applicable prize. If such a potential winner is not available or if there is no answer at the time any notification telephone call is made, a phone message will be left (if possible). Any such phone message will instruct the potential winner to call a specified telephone number within three (3) full business days after the time that the notification message was left. Potential winner must reply as instructed to identify him/herself, confirm his/her eligibility and ability to accept the prize, and provide his/her complete contact information within such three (3) full business day period, or he/she will be disqualified. In Sponsor's sole discretion, such potential winners may only be notified one time as set forth above for attempted prize notification. Each potential Grand Prize winner will subsequently be required to complete an affidavit/declaration of eligibility, a liability release and (where legal) a publicity release, which will be sent to the potential winner by Promotion Mechanics, Inc. by email, postal mail, or express mail, and must be returned within the time period specified in potential winner's notification letter or email. Proof of identity, age, and legal residence may be required to claim a prize. Grand Prize winners will also be required to return an IRS W-9 form within the time period specified by Sponsor, and such winner will receive an IRS Form 1099 issued in his/her name for the actual value of prizes received. Grand Prize winners must pick up their prizes at the store associated with their winning entry within 30 days of notice of availability, and all winners hereby grant permission to Sponsor to be photographed for publicity as part of the prize claim process. Any Grand Prize winner or potential Grand Prize winner may be disqualified (and the applicable prize forfeited) in Sponsor's sole discretion if: (a) the applicable winner or potential winner fails to reply or to provide any required information or properly completed documents within the required time period, (b) the applicable winner or potential winner fails to comply with any of the terms of these Official Rules, or (c) if any prize or prize notification is returned as undeliverable, any voice mail or message left is not timely returned, any forms sent to potential winners are not timely returned as instructed, or any prize is not picked up within 30 days of notice of availability. In the event of Grand Prize forfeiture, at Sponsor's sole discretion the applicable Grand Prize may be awarded to an alternate winner selected from among the remaining applicable eligible entries via the means of winner determination described herein, pending verification of eligibility. If any prize remains unclaimed after three (3) potential winners have been notified for that prize, the prize may remain unawarded, in Sponsor's sole discretion. No responsibility is assumed by Sponsor for any incorrect or missing postal address, email address or phone number associated with an entry, or any change of address, email or phone number of participant after entry submission.

6. ADDITIONAL DETAILS AND RESTRICTIONS FOR ALL PARTICIPANTS: Each Game Card can only be used/redeemed once. Any prize/offer details and restrictions not specified will be determined by Sponsor in its sole discretion. No prize/offer transfer. Unless otherwise specified herein, no prize/offer substitution except at Sponsor's sole discretion due to unavailability, in which case a prize/offer of comparable or greater value will be provided. All other costs and expenses associated with acceptance and use of a prize/offer not specified herein as being included are the sole responsibility of the applicable participant. Sponsor will not replace any lost, damaged or stolen prizes or Game Cards. Any difference between the approximate value and actual value of a prize (or any substitution prize) will not be awarded. All taxes (including without limitation federal, state and local taxes) in connection with a prize, and the reporting consequence thereof, are the sole responsibility of the applicable winner. Sponsor makes no representations regarding the tax liability associated with any prize, and winners are advised to seek counsel regarding any tax liabilities associated with their prize. Unless otherwise indicated herein, all prizes and offers are provided as-is and without warranty of any kind, implied or express. No responsibility is assumed by Sponsor for any incorrect or missing contact information associated with an entry or prize/offer claim, or for any change of contact information of a participant after submission.

7. GENERAL CONDITIONS: Sponsor and any other prize/offer suppliers, their respective parents, affiliates, subsidiaries, advertising or promotion agencies, and any companies and individuals engaged in the development, production, or promotion of the Promotion (including Promotion Mechanics, Inc.), together with the employees, officers, directors, and agents of each (aforementioned organizations and individuals collectively, the "Releasees") are not responsible and shall not be liable for: [a] late, lost, stolen, misdirected, delayed, illegible, inaccurate, or incorrect Game Cards, entries, forms, mail, or prize claims, or for postage-due mail; or [b] any other failures, problems, malfunctions or errors whether caused by equipment, human error, or otherwise relating to or in connection with the Promotion, including, without limitation, errors which may occur in connection with the administration of the Promotion, the processing of Game Cards or prize/offer claims, the announcement of the prizes/offers or winners, or for printing, typographical, human, seeding or other errors in connection with this Promotion or other such errors appearing in these Official Rules, on any Game Cards or in any Promotion-related materials. By participating in the Promotion, participants hereby agree to: [a] abide by these Official Rules and by the decisions of Sponsor, whose decisions are final and binding on all matters pertaining to this Promotion, [b] the use of their names, photographs, testimonials or other likeness and/or prize information or personal exposition (and/or any edited portion thereof) by Sponsor and its designee(s) for promotional, advertising and/or publicity purposes in any media, now or hereafter known throughout the universe in perpetuity, including but not limited to the posting of their names online, without compensation or notice to, or further consent of, to the winner to the extent permitted by law, and [c] to release, discharge and hold harmless the Releasees from any and all injuries, liability, losses and damages of any kind resulting from their participation in the Promotion (including, but not limited to, any travel related thereto) or their acceptance, use or misuse of any prize/offer obtained via this Promotion, including, without limitation, personal injury, death and property damage. All federal, state and local laws and regulations apply. **CAUTION: ANY ATTEMPT BY A PROMOTION PARTICIPANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE ANY WEB SITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE PROMOTION IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR AND ITS DESIGNEES RESERVE THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.** Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or any web site associated therewith, to be acting in violation of the Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. Although Sponsor attempts to ensure the integrity of the Promotion, Releasees are not responsible for the actions of participants or other individuals in connection with the Promotion, including participants' or other individuals' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Promotion. In the event of any conflict between any Promotion details contained in these Official Rules and Promotion details contained in any Promotion advertising materials or disclosures, the details of the Promotion as set forth in these Official Rules shall prevail. If, for any reason, the Promotion is not capable of running as planned by reason of damage by computer virus, worms, bugs, tampering, unauthorized intervention, fraud, technical limitations or failures, strikes, industry conditions, bankruptcy or liquidation, marketplace demands, applicable law, unforeseen obstacles, or any other causes which, in the sole opinion of Sponsor, could corrupt, compromise, undermine, or otherwise affect the administration, security, fairness, integrity, viability, or proper conduct of the Promotion, Sponsor reserves the right in its sole and absolute discretion to cancel, terminate, modify, or suspend all or any part of the Promotion, and to select the applicable winner(s) from among the applicable eligible, non-suspect entries or claims received up to the time of such cancellation, termination, modification, or suspension, as applicable, or to proceed in such a manner as may be deemed fair and equitable by Sponsor in its sole discretion. In no event will Sponsor be obligated to provide more prizes/offers than the number of prizes/offers stated in these Official Rules, at any prize/offer level and in connection with any participating Haggen store. If, due to a printing,

production, typographical, mechanical or other error, the number of prize claims received is greater than the listed number of prizes at any prize level for a participating Haggen store, such listed number of prizes (or in Sponsor's sole discretion, the number of available prizes remaining at such prize level for the applicable Haggen store, at the time such error is discovered) will be awarded in a random drawing from among all eligible participants who: [a] submit a legitimate prize claim for that level in connection with the applicable Haggen store; and [b] have not already received one of the applicable prizes prior to the discovery of such error. Any purported evidence of winning will not be accepted in place of Sponsor's own methods of winner verification. The Releasees' failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. By participating in this Promotion, participants agree to waive any right to claim ambiguity or any deficiency in these Official Rules or the Promotion (including its administration), and further agree to be bound by Sponsor's interpretation of the terms of these Official Rules, which shall be final.

8. ARBITRATION/CHOICE OF LAW: By participating, except where prohibited, each participant agrees that: (a) any and all disputes, claims, and causes of action arising out of or connected with this Promotion, or any related prize or offer, or the determination of the prize/offer recipient(s), must be resolved individually, without resort to any form of class action, and exclusively by binding arbitration pursuant to the Rules of the American Arbitration Association, then effective; (b) the place of any arbitration shall be in Whatcom County, Washington, and each participant irrevocably waives any and all rights to object to such location; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion but in no event attorneys' fees or other legal costs; (d) under no circumstances will a participant be permitted to obtain awards for and participant hereby waives all rights to claim punitive, special, indirect, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased; and (e) judgment on any award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participants and the Releasees in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the State of Washington with jurisdiction and venue in Washington, without regard for conflicts of law doctrine, and all proceedings shall take place in the appropriate court located in the State of Washington.

9. COLLECTION AND USE OF PERSONAL INFORMATION: By participating in the Promotion, participants agree and consent to Sponsor's collection, use and retention of their personal information provided in the course of their participation for all purposes related to the Promotion (including, without limitation, processing and administering entries, sharing a participant's personal information with Sponsor's service providers, contractors, and prizing partners, as necessary to conduct and operate the Promotion, communicating with and awarding prizes to winners, making public announcements about winners, and advertising, promoting and publicizing the Promotion), as well as in accordance with Sponsor's Privacy Policy published at <https://www.albertsoncompanies.com/about-us/our-policies/privacy-policy.html>.
